Be a Borough resident for at least 30 days;

Be a registered voter of the Borough;

1) a Declaration of Candidacy form;

2) a Petition for Candidacy form signed by at least twenty qualified voters of the Borough; and

- 3) a Municipal Exemption Statement obtained from the Borough Clerk. File this
- statement if the candidate does not expect to spend over \$5,000 on his or her campaign.






Voter Qualifications and Last Day to Register for October 1, 2024 Municipal Election

Voter qualifications for the Petersburg Borough October 1, 2024 Municipal Election are as follows:

- 1. A United States citizen
- 2. Registered and qualified to vote in the State of Alaska elections and registered at least thirty days immediately preceding the municipal election;
- 3. At least eighteen (18) years of age;
- 4. A resident of the Petersburg Borough for thirty (30) days preceding the election;
- 5. Not disgualified by reason of having been convicted of a felony involving moral turpitude, and if so, that civil rights have been restored.
